## CALL FOR APPLICATIONS FOR 1 STUDENT EXCHANGE MOBILITY REIMBURSEMENT TO THE UNIVERSIDADE CATOLICA DOM BOSCO (UCDB), CAMPO GRANDE, BRASIL SEMESTER 2, ACADEMIC YEAR 2016/17

The Department of Historical and Geographic Sciences and the Ancient World (DiSSGeA) announces a competition for n. 1 student exchange mobility reimbursement for stays to be carried out at the *Universidade Catolica Dom Bosco (Campo Grande, Brazil*) during the second semester of the academic year 2016/17, from 1<sup>st</sup> March to 30<sup>th</sup> August 2017.

Only candidates that, at the time of their application, meet the following requirements are considered eligible for the exchange programme:

- a) in the academic year 2015/16 they have been enrolled as self sponsored students in their first year of studies within the Erasmus Mundus Master of Science in Sustainable Territorial Development (STeDe);
- b) during their first year of studies (academic year 2015/16) within the Erasmus Mundus Master in Sustainable Territorial Development (STeDe), they have gained at least 48 ECTS credits; in the academic year 2016/17 they will enroll in their second year of studies;
- c) their study plan states that their fourth semester, dedicated to the implementation of the Internship and Thesis, has to be spent at the *Universidade Catolica Dom Bosco* (Campo Grande, Brazil).

Selection of candidates will be based on their merit, motivation, socio-economic conditions (proved by a self-certification).

The exchange programme also foresees the following conditions:

- a) Before departure and for the whole duration of his/her stay abroad, the student participating in the exchange will be enrolled in the Erasmus Mundus Master Degree in Sustainable Territorial Development (STeDe); he/she will be exempted from paying any tuition fees at the Host University
- b) The University of Padua (via the International Relations Office) will transfer the selected student a reimbursement of up to 800 Euros for each month he/she has lived abroad, as to cover the costs of travel, board and lodging and all other expenses incurred by the student during his/her mobility.
- c) The winner will be allowed to use the facilities available at the Host University canteens and cafeterias; he/she will be assisted by the offices of the *Universidade Católica Dom Bosco* (UCDB) in finding a suitable accommodation.

For the purposes of the selection, candidates must submit the following documents:

- Application form, edited and filled out on plain paper, as per the attached template;
- Motivation letter, written in English, and plan of the activities to be carried out at the *Universidade Católica Dom Bosco* (UCDB).
- Self-certification concerning the exams passes and the marks obtained by the candidate within the Erasmus Mundus Master in Sustainable Territorial Development (STeDe) up to the date submission of his/her application;
- Self-certification related to the candidate's economic/ social conditions;
- Other qualifications that the candidate may consider relevant for the evaluation of his/her application.

Application and annexes are due on July 31<sup>st</sup> 2016, before midnight. A scanned copy of the application form and annexes must be sent by e-mail to the following address: e.serrano@unipd.it.

The assessment of candidates will take place on the  $10^{th}$  of September 2016, at 10 am, at the DiSSGeA Department, Geography Building.

Selection of candidates will be carried out by a specific Evaluation Committee, which will examine the application packages and eventually contact the candidates via Skype as to fully assess their motivations, their curriculum and qualifications.

The Commission will provide a ranking of eligible candidates and publish it on the website of both the DiSSGeA Department and the STeDe Master Course, at the following web pages:

The name of the winner will be announced to the Universidade Católica Dom Bosco (UCDB) for the evaluation

of his/her application: in any case, it is up to the Host University to finally accept the selected student, who will then receive an official letter of invitation /acceptance.

The student selected for the exchange mobility reimbursement will have to communicate his/her formal acceptance by e-mail to the following email addresses: e.serrano@unipd.it AND francesca.mura@unipd.it no later than five days after the date of publication of the selection results. Should the student not meet such deadline, he/she will not be awarded the exchange mobility reimbursement. In case the winner does not accept the exchange mobility reimbursement, the following suitable candidate will take over, according to the final selection list.

Before departure, the winner of the exchange mobility reimbursement must submit his/her own learning agreement for approval to the competent STeDe Master Degree Board.

Studies and activities being carried out at the partner university will be recognized by the DiSSGeA Department according to the University of Padua Academic Senate deliberations 08.03.91, 10.07.92, 05.09.95.

Upon arrival to the Host University the student must report to the International Office to fill out and submit a certificate proving the beginning date of his/her stay; at the end of the period spent abroad, the student must request to the Host University a final certificate proving the duration of his/her stay, a Transcript of Records, and any other useful documents he/she should hand in upon his/her return to Italy.

On his/her return to Padua, the student will have to hand in to the University International Relations Office (Via Roma 38, second floor) the following documents:

- Original certificate issued by the Host University, stating the beginning and end date of the period the student spent abroad;

- Airline tickets and original boarding passes as well as original receipts related to board and lodging expenses the student has undertaken during his/her mobility;

- Detail of the student's bank account (of which he/she must be the holder or co-holder) to which the refund will be transferred.

The student will have to address to his/her teachers for the recognition of the activities he/she has carried out abroad. He/she will have to give proof of the Internship he/she has completed and provide a brief report on his/her activities.

As for health care, the student must personally take charge of his/her insurance coverage.
